## OPEN POWER GRIDS ACCESSION AGREEMENT

(A) By the Open Power Grids Articles of Association dated 12 May 2022 and as now in force pursuant to any Accession Agreement entered into by any other new Acceding Member before the date of this Accession Agreement, the Founding Member agreed to give effect to and be bound by the Association;

(B) The Association has the purpose to share the "OPEN POWER GRIDS Functional Technical Specifications" ("OPG Functional Technical Specifications"), intended for any interested stakeholders (e.g. Asset Owners and Operators, Manufacturers, Engineering-Procurement-Construction Companies, Educational Institutions), including the possibility to amend the OPEN POWER GRIDS Functional Technical Specifications according to the terms and conditions of the Open Power Grids Articles of Association;

(C) The Acceding Member has complied with the Accession Requirements and wishes to be admitted as [Full/Associated] Member of the Association under the Open Power Grids Articles of Association.

NOW THEREFORE, on the basis of the WHERAS above, IT IS HEREBY AGREED as follows:

1. In this Accession Agreement words and expressions defined in or for the purposes of the Open Power Grids Articles of Association and not otherwise defined herein shall have the meanings given thereto under the Open Power Grids Articles of Association. 2. The Association (acting on behalf of each of the Members) hereby admits the Acceding Member as party under the Open Power Grids Articles of Association on the terms and conditions hereof.

3. The Acceding Member hereby accepts its admission as a Party and hereby undertakes to duly perform any and all duties and obligations related to the Open Power Grids Articles of Association as a Member as from the date hereof.

4. For all purposes in connection with the Open Power Grids Articles of Association, this Accession Agreement shall as from the date hereof be treated as part of the Open Power Grids Articles of Association, and all rights, duties and obligations of the Parties (also including the Antitrust Compliance Guidelines that the Acceding Member hereby declares to have read and accepted) shall be construed accordingly.

5. This Accession Agreement and the Open Power Grids Articles of Association shall be read and construed as one document and reference (in or pursuant to the Open Power Grids Articles of Association) to the Open Power Grids Articles of Association (howsoever expressed) should be read and construed as reference to the Open Power Grids Articles of Association and this Accession Agreement.

6. The Acceding Member will authorize the Association to list the Acceding Member's name and logo on the Association platform, web site, advertising and/or promotion material as from the date hereof. Nevertheless, if the Acceding Member requests to provide the Association with explicit instructions and/or limitations to the authorization in accordance with art. 6.3 of the IP Framework Agreement, such instructions and limitations should be enclosed to this Agreements as an integrative signed note.
