

Annex 2 OPEN POWER GRIDS Accession Agreement



This Accession Agreement is signed on	from and between:

(2) Open Power Grids Association (the "Association"), association established on May 12, 2022, with registered office in Rome.

GIVEN THAT

(A) Pursuant to the Open Power Grids Articles of the Association dated May 12, 2022, currently in effect, pursuant to an Accession Agreement entered into by any new Adhering Associate prior to the date of this Accession Agreement, the Founding Member has agreed to give effect to and be bound to the Association.

(B) The Association aims to share functional specifications ("Functional Specifications"), intended for all interested parties (for example, Owners and Asset Operators, Constructors, Engineering-Contracting-Construction Firms, Educational Institutions), including the possibility to modify the Functional Specifications according to the terms and conditions of the Open Power Grids Articles of Association;

(C) The Adhering Associate is Eligible for Accession and wishes to be admitted as an Associate of the Association under the Open Power Grids Articles of the Association.

Given the above, based on the above, YOU AGREE as follows:

1. In this Accession Agreement, words and expressions defined in or for purposes of the Open Power Grids Articles of the Association, and not otherwise defined herein, shall have the meanings ascribed to them by the Open Power Grids Articles of the Association.

2. The Association (acting on behalf of each of the Associates), hereby admits the Adhering Associate as a party pursuant to the Open Power Grids Articles of Association under the terms and conditions hereof, as Associate **indicate correct option**:

3. The Adhering Associate accepts his admission as a Party and undertakes to duly carry out all the duties and obligations relating to the Open Power Grids Articles of the Association as an Associate starting from the date of this document, also undertaking to pay the Accession fee pursuant to art. 12 of the Statute. Where the Accession concerns not only the Adherent Associate but also the companies controlled by it and listed in point





1) of this Agreement, the Adherent Associate undertakes towards the Association pursuant to art. 1381 of the civil code to ensure that the aforementioned companies meet the admission requirements and comply with all the obligations established under the Statute, with the exception of the burden of paying the Accession fee which will fall solely on the Member.

4. For all purposes with respect to the Open Power Grids Articles of the Association, the Adhering Associate will be treated, as of the date hereof, as if they were a signatory to the Open Power Grids Articles of the Association and as if this Accession Agreement were part of the Open Power Grids Articles of the Association. Furthermore, all rights, duties and obligations of the Parties must be interpreted accordingly.

5. This Accession Agreement and the Open Power Grids Articles of the Association shall be read and construed as a single document and reference (in or under the Open Power Grids Articles of the Association) to the Open Power Grids Articles of the Association (however expressed) shall be read and understood to refer to the Open Power Grids Articles of the Association and this Accession Agreement.

IN LIGHT OF THE FOREGOING, this Accession Agreement was duly executed on behalf of the parties as of the above date.
