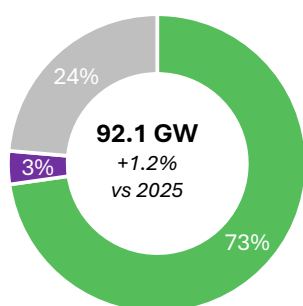

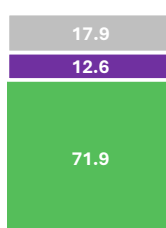

Total Net installed Capacity



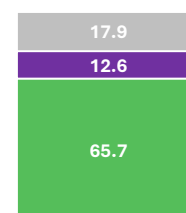

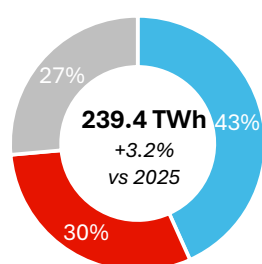

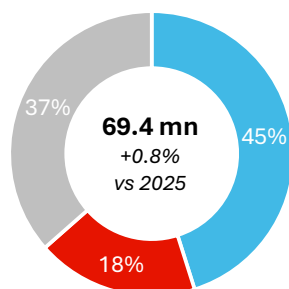
