## **ENEL COMPLETES PLACEMENT OF 5.1% OF TERNA BY AN** ACCELERATED BOOKBUILDING TO ITALIAN AND INTERNATIONAL INSTITUTIONAL INVESTORS

Placed 102,384,037 Terna shares, equal to 5.1% of the share capital, for a total consideration of Euro 281 million.

Rome, February 2<sup>nd</sup>, 2012 - Enel S.p.A. ("Enel") announces that it has completed the placement, launched late yesterday afternoon, of 102,384,037 ordinary shares, equal to 5.1% of share capital, of Terna S.p.A. ("Terna"). The proceeds of the placement totalled Euro 281 million, generating a consolidated capital gain of Euro 178 million for Enel, net of ancillary charges. The whole interest held by Enel in Terna, whose shares are traded on the Mercato Telematico Azionario ("MTA") managed by Borsa Italiana S.p.A., has been disposed.

The transaction, which was structured as an accelerated bookbuilding with the placement of Terna shares to Italian and international institutional investors, was priced at Euro 2.74 per share. The transaction will be settled through delivery of shares and payment of consideration on February 7<sup>th</sup>, 2012.

For the placement, Enel has engaged Banca IMI, J.P. Morgan, Mediobanca and Unicredit as joint bookrunners.
