### ENEL INFORMS ABOUT THE PURCHASE OF TREASURY SHARES BETWEEN NOVEMBER 17<sup>TH</sup> AND 21<sup>ST</sup>, 2025

**Rome, November 25<sup>th</sup>, 2025** – Enel S.p.A. (“Enel” or the “Company”) announces that between November 17<sup>th</sup> and 21<sup>st</sup>, 2025 it purchased 350,229 treasury shares at a volume-weighted average price of 8.7874 euros per share on the regulated market Euronext Milan, for a total consideration of 3,077,585.433 euros.

The transaction follows the announcement on July 31<sup>st</sup>, 2025 concerning the start of a share buyback program (the “Program”), implementing the authorization granted by the Shareholders’ Meeting held on May 22<sup>nd</sup>, 2025. The Program was approved with the aim to provide Shareholders with a remuneration in addition to the distribution of dividends, as a result of the cancellation of treasury shares purchased for this purpose.

On the basis of the information provided by the intermediary engaged to execute the purchases, the following table summarizes, in aggregate form on a daily basis and by trading venue, Enel ordinary share purchases carried out by the same intermediary on the period indicated above:

Since the beginning of the Program, Enel has purchased 80,887,948 treasury shares (equal to approximately 0.7956% of the share capital), for a total consideration of 634,036,310.396 euros. Considering the treasury shares already owned, Enel holds as of November 21<sup>st</sup>, 2025, a total of 91,973,190 treasury shares, equal to approximately 0.9047% of the share capital.
